



## Full-Time Psychotherapist Position

**HOURS:** Full-time

**SALARY:** \$50,000 - \$65,000 annually

This is a full-time position providing therapy services at our community clinic and local schools on the northwest side of Chicago. The work week is Tuesday through Saturday.

### **POSITION SUMMARY:**

There is an immediate need for clinicians to work with children and families, adolescents, adults, couples, and groups. The clinician is responsible for providing diagnostic assessments, therapy, counseling, and support services for a diverse caseload, including adults, adolescents, and families experiencing mental health issues, family conflict, or life stressors. Psychotherapeutic work may be provided in either individual, family, or group settings. Work will be completed in the office, at local schools, and remotely.

Candidates should have a Master's degree in Social Work or Psychology, and an independent license, LCSW, LCPC, or LMFT, or be eligible for their state clinical license. We can support current H1B Visa recipients in a Change of Employer visa transfer process.

### **RESPONSIBILITIES FOR MENTAL HEALTH PSYCHOTHERAPIST:**

- Assess clients' mental health condition based on a review of client information, interviews, observation, screening tools, and collaboration with other providers.
- Conduct initial family assessments and refer patients, clients, or family members to community resources or specialists as necessary.
- Develop and implement treatment plans based on evidence-based interventions, including clinical experience and knowledge.
- Provide psychoeducation on mental health disorders.
- Assist clients in implementing evidence-based intervention strategies and identifying barriers to treatment.
- Monitor client progress through the use of screening tools and treatment plan reviews.
- Maintain confidentiality of records relating to clients' treatment.
- Gather information about community mental health needs through validated instruments and assist with statistical analysis for research projects.
- Serve as a client advocate to coordinate required services or to resolve emergency problems in crises situations.

### **QUALIFICATIONS FOR MENTAL HEALTH PSYCHOTHERAPIST:**

- Active Illinois license as an LCSW, LMFT, or LCPC, or eligible to obtain licensure within the next 6 months.
- Maintain professional licensure throughout employment with this agency.
- Ability to work as a team member and cooperatively.
- Must be able to work a flexible work schedule, including some evenings.
- Superb organizational skills.
- Ability to guide, direct, or influence people.
- Excellent written and oral communication skills.
- Able to establish and maintain effective working relationships with diverse persons.
- Bilingual (Spanish) helpful, but not required.



- Able to conduct in-person and telehealth counseling sessions.
